Greetings and best wishes from Rome, where I am planning to celebrate the new year. But I must tell you right away that the city is no more the same as when we met: it looks rather subdued and it is not the colorful place of the time of the Ecumenical Council, though its grandeur is not missed for a minute.

I am happy to tell you that among the most delightful experiences of my last visit to Rome were my few and too short meetings with you. In addition to our conversation on serious topics, your presence put me into a frame of mind which produced real relaxation and intimacy. As far as Prof. Gasperini's (?) diagnosis is concerned and the reports in the Italian press about it, this goes on in the same way as when we were here together. It seems that he again arrived from Bologna on an unexpected train and the question is still one of why this fellow does not arrive on trains scheduled according to Il Tempo's schedules. You might also like to hear the latest story told in Rome about our mutual friend Cardinal Ottaviani. The story is that every morning after he gets up instead of saying "Mea culpa, mea culpa, mea maxima culpa" he now says "Bea culpa, etc."

I do hope George, that before long we shall meet again and that we shall have more time to spend together during the forthcoming session of the Ecumenical Council which I hope both of us shall be following from here.

You'll be interested to know that the purpose of my present visit to Rome was to take part in an audience granted by Cardinal Bea to a group of American Jewish Committee leaders. We had a wonderful conversation with him yesterday. He was in excellent spirit and in an optimistic mood with regard to the outcome of the Ecumenical Council. Everyone of us was deeply impressed by the clarity of vision, the wisdom and the precision of thought of this great statesman of the Church.

I have not forgotten my promise to send you articles on the Council which appeared in the European publications and which in my opinion would be of interest to you. As a token, I am enclosing herewith one article which I personally enjoyed very much and the author of which is the well known Father Jean Danielou, published in the weekly Figaro Litteraire. I liked this article not so much because of the factual content, which is known to us, but for the neat, elegant and gallic way with which Father Danielou summarized the first session of the Council. I hope you'll enjoy it as much as I did. I expect to send you soon some other material.

I appreciate very much your gracious invitation to call upon you whenever you can be of any assistance. I shall certainly be in touch with you at any time I feel we need your advice and help.

I assume that you are aware of the invitation extended to Cardinal Bea by the Divinity School of Harvard University. The Cardinal informed us that he has accepted this invitation and that he will deliver three lectures. He is planning to arrive in the United States on March 27. At the same time, it is also being planned to arrange an agape either in New York or in Boston, and under the auspices of both Cardinals Cushing and Spellman. This will show you that your advice to Pro Deo on this matter was taken into consideration.

I also miss in Rome these days our friend Malachi, who disappeared from Rome for unknown destinations for the holidays. In the language of the Italian press one might pose the following question: Ok, he is entitled to a rest, but why the mystery? I hope that 1963 will bring us an adequate reply to this momentous question.

Dear George:

I very much appreciated your letter of January 4, and I hope that you have succeeded in taking care of the tremendous amount of work which I imagine has accumulated during your absence.

I visited Rome twice recently, and had good conversations with some of our mutual friends. I was delighted to make the acquaintance of Father Stransky, of the Secretariat for Christian Unity, who asked me to convey his greetings to you. I found him to be very alert, energetic and "ready to fight." I was also glad to find that our friend Malachi has turned up in Rome again, and that it was possible to have many good talks and fun with him. It seems that he was away for a short time in England, for health reasons, but is now back in Rome and as active as ever.

You probably know that a delegation of American Jewish Committee leaders met with Cardinal Bea on December 28. He was in very good spirit and talked with expectation about his forthcoming visit to the U.S. He told us that the program for this visit is being arranged by Cardinals Cushing and Spellman. I do hope that you will have a chance to meet with him and his assistant, Father Schmidt; and also that you will be able to take part in the Agape.

During my recent visit to Rome I have not heard of any significant developments in connection with the Ecumenical Council. I was told, however, that the job of redrafting the schemata and reducing the 70 odd number of them to about 20 will require a colossal amount of work. It is for this reason that some of those involved in this work believe that it will be necessary

to have a third session of the Council, to take place some time in 1964. You probably know that the Central Coordinating Commission is planning to have its first session in the next few days.

I have come across some of the comments on the Council which appeared in several European countries; but thus far have not seen anything of particular significance. I must say, however, that the Italian illustrated weeklies have done an excellent job in portraying the external aspects of the Council, and in a very picturesque manner. I am thinking particularly of the two articles in the magazine "Il Tempo," which tried to describe the setting and procedure of the Council sessions dealing with the problem of liturgy. Of course, I am not in a position to say whether these reports are accurate; but I found them interesting reading, and I am enclosing them herewith.

One amusing bit of information for me was the fact that one of the two bars in St. Peter's Basilica was called Bar Jonah, and the reason for it was that Jonah was the father of Peter and, as you know, "bar" is the Hebrew word for son. (You know, of course, the term Bar-mitzvah.) By the way, my scholarly friends in Rome tell me that the name of Peter's father is mentioned only once in the New Testament. They also say that the other bar was called Barabba, which is also a Hebrew word meaning the son of the father.

At any rate, you may be sure that I shall not fail to send you any material of importance I will come across in my readings. Meanwhile, with all good wishes and looking forward to seeing you soon,

Dear George:

Druing my short visit in Indianapolis I met Ray Bosler, who conveyed to me the sad news that your father passed away. I then stopped in New York again for a short while and hurried back to Paris and Rome, from where I returned last night. This is therefore the first occasion I have to express my profound sympathy and commiseration for your great loss. It is always very difficult to find the proper words in a moment like this. There is still nothing better, I believe, than the words of Job, said at all funerals: "God has given, God has taken away, let his name be blessed from now to eternity."

Of course, while in Rome I was following matters of our concern. I found the situation rather somber and I am not very optimistic. While I have not heard anything definite with regard to what used to be Chapter V (religious liberty) the reports on the present state of what was formerly Chapter IV (attitude toward Jews) are rather disquieting.

It is believed that the plan is to eliminate what is considered by many, including myself, the heart of the matter, namely, the passage on the responsibility for the crucifixion. I hope you had occasion to discuss this matter with Cardinal Bea, on his recent visit to the U.S.

I regret very much that my short and hectic stay in New York did not permit me to visit you in Washington, as I intended to; but I look forward to seeing you soon again in Rome. Meanwhile, with warmest wishes,

I didn't do anything about the Seattle matter referred to in your last two letters, the reason being that I am not very close to Archbishop Connolly (as a matter of fact, I have met him only once or twice) and therefore wasn't in a position to know how he would react if I approached him about his article in Northwest Progress. Frankly I think your people in Seattle would be better advised to take the matter up directly with the Archbishop as soon as he recovers from the Council.

As you can well imagine, I am terribly busy at the moment, but, as soon as I can catch my breath, I hope to have an opportunity to chat with you at considerable length about the work of our newly established Commission on Catholic-Jewish Relations. I will be in touch with you about this matter as soon as I can clear my desk. Meanwhile I am sure I don't have to tell you how much I appreciate the constructive tone of your recent Statements on the Council Declaration on Catholic-Jewish Relations.
